## Call for Young Scientist Award nominees

At the EuroResidue Conference, the organisers intend to confer a scientific to a young scientist with high potential. It is, however, a challenge to assess all the talent out there in the field. It is for this reason that we are asking for your assistance and invite the residue scientist community to [make us aware of candidates for the Young Scientist Award](#).

Criteria for aspirant award holders could be originality and quality of the delivered work, but factors such as powerful representation of the profession and making the work understandable to the public can also be considered as a reason for listing a candidate. Preferably results of the nominee's work are accessible, for example publications in high-standard peer-reviewed scientific journals. Though there are no specific age-limits, the nominee should be considered "young" by generally accepted qualitative terms.

Please make your nominee, with a brief, adequate justification known to the Chair of the Scientific Committee before March 1st, 2022.

## Presentations

Abstracts are invited for consideration for oral, short flash poster presentation or poster only presentation on the different topics. The central theme of the conference will be on modern approaches in the control of veterinary drug residues, advances in analytical methods and the application of such strategies in inspection and control.

Within this context, the Scientific Committee would also welcome contributions on: aspects of residue depletion (including metabolites); 'omic' approaches; robotics; hyphenated techniques; innovation in screening and confirmatory analysis; legislative aspects; monitoring based on risk analysis and epidemiological information; antimicrobial resistance, control in third countries, analytical criteria and the environment as a source of residues in food producing animals.

## Oral and poster contributions

Are considered to be of equal status. The Scientific Committee will decide on acceptance and on the manner of presentation. Abstracts, not exceeding 200 words, should be submitted via the EuroResidue website, using the format supplied. Authors of accepted abstracts will be invited to submit full manuscripts for publication in a peer reviewed scientific journal dedicated to this symposium.
